## Learning Forward Announces Kentucky Task Force Members as Part of the Organization's Common Core Initiative

Task Force Will Support Common Core Professional Learning System in the State

DALLAS—April 3, 2012—As part of Learning Forward's initiative to develop a statewide, comprehensive professional learning system to support educators in Kentucky as the state implements Common Core State Standards (CCSS), more than 40 members of the Kentucky education community have been selected to serve on a task force to lead the initiative.

The task force, which includes representation from all stakeholders impacted by the initiative, will review current policies and recommendations to charter a new course in statewide professional development standards that is tied to the Common Core. In partnership with the initiative's advisory council, critical friends, and Learning Forward staff, the task force will develop tools such as materials, protocols, and strategies to sustain the planning and improvement of professional development in preparation of the Common Core implementation in Kentucky.

Kentucky was selected as the Demonstration State for the initiative, *Transforming Professional Learning to Prepare College- and Career-Ready Students: Implementing the Common Core*, and will receive training, coaching, and support from Learning Forward and other partner organizations over the next two years as a comprehensive plan is developed that incorporates professional learning practices and Common Core State Standards. The resources developed from the initiative will be made available to all states as they implement Common Core State Standards.

"Kentucky strives to ensure that all students are college and career ready upon graduation and have access to effective instruction and assessments based on the Common Core," said Terry Holliday, Ph.D., Kentucky Commissioner of Education.
