## Appropriations bill includes increased support for Title IIA

The 2020 U.S. Congressional appropriations bill passed in December includes a significant increase in funding for Title IIA, the U.S.’s major source of federal funding for professional learning and school leadership development.

The 3.7% increase is the first significant increase in a decade, and the highest percentage increase among any of the major title programs, including Title I.

Though short of the House’s appropriations increase for Title IIA, the \$76 million is a milestone for the field and a vital source of support for improving teaching and learning.

Denise Glyn Borders, Learning Forward’s president and CEO, said, “Our educators need and deserve an increasing level of support in every funding bill.”
